## A Year of Developments and Getting Started with Grange Court

2010 /11 has proved to be a highly successful year for LARC. The long term plans to start the work on Grange Court to convert it to a community and social enterprise hub at last began on site with building work commencing in October 2010. The £2.8 million asset transfer project is the culmination of a huge effort by many people and organisations across Leomin-

ster and Herefordshire. Building work is due to be complete in the Autumn of 2011.

The major activity over the latter part of the year was the recruitment of a manager for the Grange Court Project and the further development of the business plan. The Grange Court Manager post was advertised through the Third Sector Jobs Website, and the Social Enterprise Coalition, it was also placed on the County Council Website and a special website (<a href="www.grangecourt.org.uk">www.grangecourt.org.uk</a>) was created to provide information and application literature. This generated a wide range of interest with over 100 enquiries producing 35 good quality applications. 6 candidates were interviewed by a special committee in February 2011. Dick Ellison was the successful candidate and started work in April.

In the year the Directors agreed to seek charity registration and to ensure that the organisation was fit for purpose to be a successful charity. This process was nearing completion at the end of the year and culminated in June 2011. This also resulted in LARC changing its name from Leominster Area Regeneration Company to

LARC Development Trust.

The siting of a bronze model of Grange Court at the top of Broad Street where the building originally stood was celebrated on 1<sup>st</sup> March 2011 with an official unveiling. The model has been well received by town people and visitors alike.
